

ARTICLES OF INCORPORATION FOR THE
ESTHERVILLE-LINCOLN CENTRAL
PATRONS OF THE FINE ARTS, INC.

We, the undersigned, do hereby declare and establish a corporation under the Iowa Nonprofit Corporation Act, Chapter 504A of the 2001 Code of Iowa, and do hereby adopt the following Articles of Incorporation in connection therewith:

ARTICLE I
Name of Corporation

The name of this Corporation is the Estherville-Lincoln Central Patrons of the Fine Arts, Inc., incorporated under the provisions of the Iowa Nonprofit Corporation Act, Chapter 504A of the 2001 Code of Iowa.

ARTICLE II
Duration

The duration of this Corporation shall be perpetual, unless sooner dissolved and liquidated in accordance with the laws of the State of Iowa.

ARTICLE III
Corporate Purpose

This Corporation shall be organized for the conduct of any lawful purpose not for pecuniary profit authorized under Chapter 504A of the 2001 Code of Iowa, the express

purpose for which this Corporation is organized is to enhance, develop and promote fine arts opportunities available to the students of Estherville-Lincoln Central Community School District by improving the facilities, programs, education and performance of the fine arts within the district.

ARTICLE IV
Registered Office and Agent

The registered office of this Corporation shall be 1620 14th Avenue North, Estherville, Emmet County, Iowa 51334 and the registered agent at such address shall be Nancy Danielson.

ARTICLE V
Corporate Powers

The corporate powers of this organization include but are not limited to soliciting and receiving or to take by gift, devise or bequest any monies, stocks, bonds or instruments of value, property of a real and personal nature or any interest therein wherever situated and to make contributions, grants, gifts, transfers of property of both a real and personal nature either outright or in trust to or for the benefit of the Estherville-Lincoln Central Patrons of the Fine Arts or for the benefit of other organizations identified with and associated with the

Estherville-Lincoln Central School District which qualify as tax exempt organizations under the provisions of Section 501C(3) of the Internal Revenue Code of the United States of America. The Corporation also has those other general powers as set forth in Section 504A.4 of the 2001 Code of Iowa.

ARTICLE VI
Directors

The initial Board of Directors and incorporators of this Corporation shall be nine (9) in number and shall serve as Directors and Trustees until their successors are elected consistent with the by-laws adopted by this Corporation. The names and addresses of such persons are:
